




#### **Michael J. Bracken**




#### **Daniela Carvalho**

Among other things Tiokasin is involved with the Akantu Institute which seeks to preserve and share knowledge from various wisdom traditions in accessible, relevant formats; and host physical gatherings and ceremonies to deepen the experience of knowledge. In 2016, he received a Nomination for the Nobel Peace Prize from the International Institute of Peace Studies and Global Philosophy. Other recent recognitions include: Native Arts and Cultures Foundation National Fellowship in Music (2016), National Endowment for the Arts National Heritage Fellowship



Nominee (2017), Indigenous Music Award Nominee for Best Instrumental Album (2019) and National Native American Hall of Fame Nominee (2018, 2019). He was awarded New York City's Peacemaker of the Year in 2013. Recently, he was also nominated for "the 2020 Americans for the Arts Johnson Fellwship for Artists Transforming Communities".



#### **Edgar E. Gutiérrez-Espeleta**

Edgar is Costa Rica's former Minister of Environment and Energy for Costa Rica from 2014 to 2018. He was also the President of the Second and Third United Nations Environment Assembly in 2016 and 2017. Edgar has B.Sc. in Statistics from the University of Costa Rica, and his M.Sc. and Ph. D. in Forest Biometry from Iowa State University, USA. He was Full Professor at University of Costa Rica from 1994 to 2014. 




#### **Fang Hong**

Before joining UNESCO, he was Head of the German Secretariat for the UN Decade of ESD at the German Commission for UNESCO from 2004 to 2011. 
#### **Amorita Ivonne Salas Westphal**
